Administrative Support Remit	<ul> <li>ESPE Team</li> <li>To develop ESPE's Communications Strategy, in line with ESPE's overall strategy</li> <li>To develop yearly communication plans to communicate ESPE's activities, information and priorities to the ESPE membership and wider community</li> <li>To have overall responsibility for the approval of ESPE communications</li> <li>To contribute ideas, insight and content for ESPE communications to ensure that important ESPE information is disseminated appropriately</li> <li>To oversee and contribute to the evolution and development of the ESPE website</li> <li>To oversee and contribute to the evolution and development of other ESPE communications as appropriate, in line with the communications strategy</li> <li>To oversee and contribute to ESPE's social media activity</li> </ul>
Additional notes	<ul> <li>Committee members should make every effort to attend all meetings, with Ex-Officio members attending at least one per year. Any Committee member who does not attend a meeting for a year will be asked to step down, other than in exceptional circumstances.</li> <li>Only Committee members should attend the meetings; no representatives should attend unless expressly agreed by the Chair.</li> <li>All Committee members need to be paid up members of the Society.</li> </ul>

•	All papers and minutes must be treated in strictest confidence.
•	All Committee members must act in the best interest of the Society.
•	Any passwords and logins provided to Committee members to enable their roles should not be shared with anyone.
•	Any potential conflicts of interest should be declared at the start of the meeting or as they arise, and the member concerned should take no part in the discussion.
•	All members can serve a second consecutive term of office. Members may be asked to take ownership of specific projects being managed by the Communications Committee (for example: website, social media, sponsor communications)
